NOTICE IS HEREBY GIVEN that the EL MONTE UNION HIGH SCHOOL DISTRICT (“DISTRICT”) invites and will receive sealed bids for the award of a contract for Bid No. 2011-P12(2), Rosemead High School Basketball Courts up to, but not later than, February 15, 2012 at 10:00 a.m. P.S.T. (“Bid Submission Deadline”) at the offices of the DISTRICT located at **1003 Durfee Avenue, El Monte, California 91733**, after which time bids will be publicly opened and read aloud. The DISTRICT reserves the right to reject any or all bids or to waive any irregularities or informalities in any bids or in the bidding process. All interested persons are invited to attend the bid opening.

The contemplated bid involves playground resurfacing to include three (3) concrete basketball courts, two (2) asphalt volleyball courts, added security fencing and gates, and drainage revisions at the Rosemead High School campus:

The DISTRICT will conduct Pre-Bid Conferences and Site Walk on February 6, 2012, at 3:30 p.m. at **Rosemead High School, Administration Building, 9063 E. Mission Drive, Rosemead, CA 91770.**

Prospective Bidders should allow at least 1 hour Pre-Bid Conference and Site Walk. ALL PROSPECTIVE BIDDERS SHALL BE REQUIRED TO ATTEND BOTH PRE-BID CONFERENCES AND SITE WALK IN ORDER TO SUBMIT A BID. PROSPECTIVE BIDDERS SHALL ALSO BE REQUIRED TO SIGN AN ATTENDANCE LOG AT BOTH PRE-BID CONFERENCE AND SITE WALK AS A CONDITION TO SUBMITTING A BID. Bidders who fail to sign-in shall be deemed absent and shall not be entitled to submit a Bid.

Bids must be accompanied by a bidder’s bond, cashier’s check or certified check (hereinafter, the “Bid Security”) for TEN PERCENT (10%) of the amount of the bid. The bidder’s bond or certified check shall be made payable to the EL MONTE UNION HIGH SCHOOL DISTRICT and shall be given as a guarantee that the bidder will enter into a contract if a contract is awarded to the bidder, and will be declared forfeited, paid to, or retained by the DISTRICT as liquidated damages if the bidder refuses or neglects to enter into a contract on the terms of the accepted proposal

within fourteen (14) calendar days after bidder's notification of DISTRICT's acceptance of the proposal. No bidder may withdraw any bid for a period of SIXTY (60) calendar days after the date set for the opening of bids.

**Prevailing Wage Rates; Employment of Apprentices.** The Project is subject to the provisions of Labor Code §§1720 *et seq.* and regulations set forth in Title 8 §§16000 *et seq.* of the California Code of Regulations which govern the payment of prevailing wages on public works projects. All bidders shall be governed by and required to comply with these statutes and regulations in connection with the Project. Pursuant to Labor Code §1771, the Contractor receiving award of the Contract and Subcontractors of any tier shall pay not less than the prevailing wage rates to all workers employed in the execution of the Contract. Bidders shall comply with applicable statutes and regulations, including but not limited to Labor Code §1771, 1775, 1777.5, 1813 and 1815.

Bidders are directed to Article 4.17 of Section 00725 (General Conditions) for detailed requirements concerning payment of prevailing wage rates, payroll records, hours of work, and employment of apprentices, and the District's LCP requirements and enforcement procedures.

Bids shall be made on the forms prepared by the DISTRICT.
