It is understood that the DISTRICT reserves the right to reject all bids; waive informalities in the bids or in the bidding; and that this bid shall remain open and not be withdrawn for a period of SIXTY (60) DAYS from the date prescribed for the opening of this bid.

For purposes of this Bid Form, the term “Contract Documents” means and includes the following bid documents contained in the Bid Packet for Bid No. 2011-12(2) (Rosemead High School Basketball Courts): the Notice Inviting Bids, the Instructions to Bidders, this Bid Form including the Bidder’s completed Bidding Sheet; Designation of Subcontractors; the Specifications; the Purchase Agreement; the Notice Re: Criminal Records Check; the Criminal Records Check Certification; the Drug-Free Workplace Certification; the Non-Collusion Affidavit; Site Certification; the Workers’ Compensation Certification; the Prevailing Wage and Related Labor Requirements Certification; the Disabled Veteran Business Enterprise Participation Certification; the Performance Bond; the Labor and Materials Bond and any notices and/or addenda issued by the DISTRICT. For purposes of this Bid Form, the capitalized term “Specifications” involves playground resurfacing to include three (3) concrete basketball courts , two (2) asphalt volleyball courts, added security fencing and gates, and drainage revisions at the Rosemead High School campus, installation specifications attached to the Bid Packet under Section 04000 and entitled “**Rosemead High School Basketball Courts.**”

It is understood that Bidders sealed bid must include all of the following documents:

- False Claims/False Claims Act Violations; (Section 00403).

It is understood and agreed that if written notice of the acceptance of this bid is mailed or delivered personally, via e-mail or facsimile to the undersigned within SIXTY (60) DAYS after the opening of the bid, the undersigned agrees that he/she will execute and deliver to the DISTRICT an agreement in the form included in the Bid Packet in accordance with the bid

as accepted, all within five (5) days after receipt of notification of award, and that performance of the contract shall be commenced immediately by the undersigned Bidder, upon DISTRICT's issuance of a written notice(s) to proceed, and shall be completed by the Bidder in the time specified in the Contract Documents. Along with the executed agreement, the successful bid will also submit a fully executed Workers' Compensation Certification, the Drug Free Workplace Certification; a Criminal Records Check Certification and all additional documentation required under the Contract Documents.
